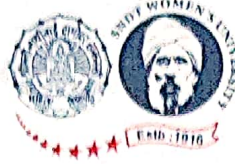

CIRCULAR

To: Principals and Academic Heads of Affiliated Colleges

Subject: Compliance with NEP 2020 Guidelines in Semester I Examination.

It has come to the University's attention that certain colleges completed teaching and conducted the first-year Sem I examinations for the academic year 2024-25 which is not in alignment with the credit structure and syllabus prescribed by the University under NEP 2020 for Semester I (for exam scheduled from 10th December to 20th December 2024).

The University views such lapses seriously, as they may result in delays in declaring results. To address this situation, the University has decided to rectify these errors on a case-to-case basis. Colleges are advised to contact the respective authority (Dean/Director of Examinations and evaluation) for updated information. However, it is imperative to note that such mistakes should not occur in the next semester

To ensure strict adherence to NEP 2020 and prevent further issues, all affiliated colleges are directed to comply with the following instructions:

1. **Selection of Courses from Baskets:**

Colleges must ensure that courses are selected appropriately from the designated baskets in every vertical, as per the NEP framework.

2. **Selected Subjects/courses:**

All selected subjects/courses must be approved by the Academic Council which are available on the website

3. **Inter-Faculty Course Selection:**

While selecting inter-faculty courses, colleges must exercise due diligence to maintain academic coherence and alignment with NEP 2020 structure.

Additionally, all affiliated colleges are required to prepare and submit a comprehensive plan of selection of subjects for credit structure for the second semester by **31 January 2025**. This plan should adhere to the aforementioned instructions and align with the NEP 2020 guidelines to ensure smooth implementation.

Failure to comply with these instructions in the future may result in strict administrative action. The University seeks your wholehearted cooperation to uphold the integrity, efficiency, and quality of education provided under the NEP 2020.

We count on your commitment to excellence and thank you for your cooperation in this regard.
